- 3) District-wise and component-wise information on the **total amount of expenditure incurred under NRHM** for the last five years from 2005-06 till 2009-10.
- 4) District-wise information on the release and expenditure incurred for **Untied Grants under NRHM** for the last five years from 2005-06 till 2009-10.
- 5) Release and expenditure of **Rogi Kalyan Samiti (RKS) Corpus Funds** for the last five years from 2005-06 till 2009-10.
- 6) District-wise expenditure under **Janani Suraksha Yojana (JSY)** for the last five years from 2005-06 till 2009-10.
- 7) Release and expenditures on **Drug Procurement under NRHM** for the last five years from 2005-06 till 2009-10.
