

My name is Miss. Maria Joseph Susairaj. On the day of incident, I was staying at Malad (West). On 6th May, 2008 I had took a flat on rent at Malad (W). I was knowing deceased MX Niraj Grever since March, 2008. He was my friend since March 2008 I was in contact of him on phone, I had met him every day from 29/4/2008 till the date of incident. on 6th May, 2008 I was shopping for whole the day for the household articles for my house. On that day 2 at about 10.30 a.m. Niraj called me on my cell phone and makked he had called me from his house. I had expressed my enability to meet him on that day because I was tired. At about 11.00 p.m. when I came out from house of my naighbour after taking a bath there, I saw that Niraj was at my the door or my house. I had introduced him to my neighbour friam Miss. Mayori. We then entered into my house. I a ked him as to why he came to my house. He said that he want to do me but help to arrange my house with the things purchased by me-on-that day.

At about 11.30 P.M. I get the phone cell from

Mr. Emil Jerem to whem I intending to marry. I told him that Niraj is at my home. Mr. Emil gave me phone call from Cochin. The phone Battery of my Cell phone MR by that time was discharged. Then Mr. Emil had called me on the cell phone of Mr. Niraj. We had talked with me. I had

told Mr. Emil that Mr. Niraj is acting very funny on that .

Immediately, thereafter, Mr. Emil started giving first blews to Mr. Niraj. Both are started fighting with other. I could not control them. Both had pushed me. So you I fell down. At the time, I when I get up I saw that Emil stabbed Niraj by means of knife of my kitchen. I tried to hold the knife at stabbing to Niraj by Emil. I had also sustained injury on my right hand palm. Again Mr. Emil pushed me and started stabbing Mr. Niraj by said knife.

I saw Mr. Niraj fell down and Mr. Emil giving kicks to Mr. Niraj. I was screaming by said incident. Mr. Emil closed my mouth. and/also threatened me to kill. Po let

me on the bed, and raped on me. He rever put the knife

Then Mr. Emil came inside the bathroom and again raped mo.

After 11.00 A.M. Mr. Emil had asked me to call one of the friend of Mr. Niraj and asked me to inform him that Miraj had left my home at 12.30 night and he has forgotten his cell phone in my house. I Mr. Emil had also teld me that I should inform that he should come to my heme and collect cell photo of Mr. Niraj from my house.

t had called Mr. Nishaht on call shore of Mr. Niraj He speke to me and tall him accordingly as directed by Mr. Emil. Mr lishat did not appear to my house.

than Mr. Emil had dragged the body of Mr. Niraj inside the pertion of the of bathreem of house.

Mr. Emil then teld me to go and purchase (bags) and curtains from Rypercity Mall at Malad. Re did not tell me for what purpose he asked me to purchase these things. Re also instructed me to kuy a knife, remu (freshner). I bought all these 4 things and came back to my house. when I was away from my house for buying those things Mr. Emil was talking with me on cell phone. When I came at my house, he had empted two of my big bags. I had to handed ever the knife to him. He asked me not to come inside the The party of the had also empted all these pelythine bags which

I was having in my home with the things purchased earlier by me. He asked me to clean the hall which was blood staimed. He asked me whether any of my friend have any car because he could not tried to contact his friends for having car.

At about 3.00 p.m. I called my friend Mr. Kiran

who is staying at Peur Bunglows, Andheri(W). By that time, Mr. Emil had chopped XMXXXXXXXXX into pieces the entire deadbody of Mr. Niraj.tn Mr. Kiran had asked me on my phone to collect the car by coming at his house. Myself and Mr. Emil both want to collect the carry hiring autorickshaw. Kiran had asked me as to who I want his car. I tell him that Mr. Emil want to go to his town. So he handed/hig/car. We took the car of Ar. Miran and came to Petrol Pump in Lekhandwala area. I was driving the said car. When I. was filling the setrel, - in the car, Mr. Emil get down and known (bought two plastic cans). Then he filled one of the can with 5 litre petrol from the said petrol pump. We then came to my home. He then put all the things in of Niraj with chepped pieces of to his body inside two big bags and also torn two/matresses into the pieces. He had covered it with the bags. He brought all those bags and put in the car. He asked me to drive the said car. The car was driven by me Western Express Righ Way. I was not knowing the area where I m was asked to drive the car. While driving the car, I had cross 3 KNXX post then he asked me take 'U' turn. Then I took the car to left cross read, In between the 3rd and 2nd XXX post of R Western Express Righ Way. Then I dreve the car on Eachcha Read. It was about 7.00 to 7.30 p.m.



I had stopped the car near small piece of land near to the readside. He took/all the bags from the car one by one and carried to 15 mx meters away from car. On the Express w Righway itself, he get filled another can with petrol and also bought one lighter. I mank only went to ar to him to give him the cans of petrol. I came back and sat in the car. He had poured the petrelling over all these bags and set on fire by lighting it with lighter. He then returned to car. He set with me and I drove the car till we reach to Express Righ way. On the Righway Mr. Emil started driving car. Then we came to my house. As I had injury to my palm, I could not work. So, Mr. Emil had started cleaning my house for removing blood string. On the way, he had asked the shop-keeper of matresses for sticking of matresses cover. Two beyes from the shee ware joined to us and they took away matress for stichir; of covers. We returned to back our home at about 9.30 p m. Mr. Emil, asked me to call the broker so that he can trange for getting paint the walls of my house. Accordingly, I had called the broker for getting paint to the walls of my house.

At about 10.30 p.m. friend of MEX Niraj, Mr. Nishat called me on my cell phone. He informed me that Niraj could not found, so he MEXEX werried. He came to my building to collect the cell phone of Mr. Niraj. one Mr. Beepak was also with him. I gave cell phone of Mr. Niraj to Nishant. They asked me to join them for lodging police complaint about missing of Mr. Niraj. I went alongwith them to Malad police Station, but Mr. Emil remained at my home. I don't know what complaint was lodged to police station by Mr. Nishan My statement was also recorded be at Malad police station. I

on 8th May, 2008 in merning, Mr. Emil had

with my laptop bag, m hand bag and one bag and put the
foot mat in brin the said bag and went to throw it. All these
things were having blood stains. By 8.30 A.M. we went to
house of Mr. Kiran and craft returned the car to him. I also
given the key of house to broke to paint to my house.

By 9.00 A.M. we went to police station. A whole day, we
were at police station till 3.00 c.m. We were again called
in mom evening at Police station. After attending the police
station Mr. Emil had that the flieght for Cochin and
left the bombay. I remained in the police station till
next day afterney, that informed to my relatives and my
family members. My brother and sister came Bembay from Mhaiseer.

All the way, I had been in centact on the phone with Mr. Emil till I confessed before the police. All the while, he was threatening me not to tell anything to the police otherwise he will kill me and also kill himself. I say that Mr. Emil had killed Mr. Niraj infront of me.

I had also took the pelice to the places where Mr. Emil burnt the body of Mr. Niraj.


